DPW Update - Mr. Freunscht provided the following information:

It was mentioned that the Valley Acres survey by Forrest SeGuin is taking too long. Mr. Freunscht will follow up.

Negotiations are ongoing with Demario to change hauling our sludge to Demario's composting facility rather than to the Madison County landfill.

Trustee Wehner stated that he was glad to see the WWTP report.

Trustee Kopp made a motion to approve the reports as presented. Trustee Wehner seconded the motion. All in favor. Motion carried

New Business

Mayor - Adopt 2025-2026 Final General Fund and Sewer Fund Budgets

Mr. Freunscht advised that the Clerk's Revenue line was cut from \$2,000 to \$500; \$47,000 has been earmarked in the Capital Account for Building Expenses and \$75,000 for DPW Equipment. Trustee Wehner stated that he wanted the Village Tax Rate to be lowered back to 6.82 from 6.95. Trustee Wehner made a motion to change the 2025 Village Tax Rate to 6.82. Trustee Kopp seconded the motion. Trustee Horning voted in the affirmative. Trustee Baldwin abstained. Motion was carried. Having no further discussion, Trustee Baldwin made a motion to adopt the General Fund and Sewer Fund Budgets. Trustee Horning seconded the motion. All in favor. Motion carried

Adopt Resolution for Harriet Tubman Underground Railroad New York Scenic Byway Nomination and Corridor Management Plan Adoption

Mayor Cianfrocco explained that the resolution asks for support of the designation of the Harriet Tubman Underground Railroad New York Scenic Byway which traverses New York State from New York City to Niagara Falls in order to support future Byway program development. Trustee Kopp made a motion to adopt the Resolution for Harriet Tubman Underground Railroad New York Scenic Byway Nomination and Corridor Management Plan Adoption. Trustee Horning seconded the motion. Discuss Recognition of Dave Mirra

There was some discussion regarding how the Village might honor Village native Dave Mirra (April 4, 1974 – February 4, 2016). Dave was an American BMX rider who also competed in rallycross racing. He set the record for most medals in BMX Freestyle at the X Games. Some ideas discussed: plaque at the skateboard park; containerize one of his bikes at Recognition Park. This will require further discussion and consideration.

Summer 2025 Community Policing Initiative Update

Chief Broton provided some information regarding the walking patrols through the Business District. He also advised that the Village PD is purchasing two electric assist bikes to help with the patrols. The PD is staying on top of vehicles that are passing school buses.

Discuss Bolivar Heights Intersection

There was discussion regarding placement of a STOP SIGN at the intersection of Burning Hollow Drive and Horizon Drive. That area is used as a cut through to Bolivar Road and traffic goes too fast through there. Mr. Freunscht stated that a local law would have to be passed for a three-way stop. Attorney Bell said that she would look at the Vehicle & Traffic Law to see if this could be accomplished through an Order rather than a Law.

Trustee Kopp made a motion to have Village Attorney Bell investigate a possible Order to accomplish a three-way stop in this area. Trustee Baldwin seconded the motion. All in favor. Motion carried.

Betterment Day Update

Trustee Baldwin advised that all is set for April 26th. Each group has their selected area for cleanup. Some groups may postpone their time for cleanup to avoid the rain that is expected. Harrington Cemetery is the only area needing coverage. (PLEASE NOTE: Karen Hawkins, Caroline Brazeau and Joanne Lesko began the cleanup process in Harrington Cemetery on Betterment Day).

Accept Resignation of Zoning/Planning Board Secretary Jill Doss

RESOLUTION FOR HARRIET TUBMAN UNDERGROUND RAILROAD NEW YORK SCENIC BYWAY NOMINATION AND CORRIDOR MANAGEMENT PLAN ADOPTION

Resolution for Harriet Tubman Underground Railroad New York Scenic Byway Nomination and Corridor Management Plan Adoption

WHEREAS, the historic qualities of the Harriet Tubman Underground Railroad New York Scenic Byway, as described in the corridor management plan, and the surrounding areas have been appreciated and celebrated for over a century by the residents of New York State, as well as tourists, historians, artists, authors, and other visitors to the region; and it is this unique combination of the journeys of Harriet Tubman and those Freedom Seekers who traveled on the Underground Railroad that create the special sense of place that is vital in telling the New York story of the human desire for freedom and the historic sites they created during their journey to emancipation; and

WHEREAS, the Steering Committee of the Harriet Tubman Underground Railroad New York Scenic Byway, composed of representatives of 22 municipalities along the proposed scenic byway route, committed to work cooperatively to protect and promote the historic, scenic, recreational, and economic well-being of the 544-mile Corridor throughout the state and agreed to pursue the nomination of the Harriet Tubman Underground Railroad New York Scenic Byway; and

WHEREAS, under the leadership of the Harriet Tubman Underground Railroad New York Scenic Byway Steering Committee, each of the 22 counties contributed to the development of this corridor management plan by forming local byway groups, encouraging public participation, and leading individual meetings of the Collaborative; and

WHEREAS, the Advisory Committee of the Harriet Tubman Underground Railroad New York Scenic Byway, consisting of relatives of Harriet Tubman, descendants of Freedom Seekers, Harriet Tubman and/or Underground Railroad historians, representatives from state and federal agencies has strengthened the historic integrity, representation, and the principles of the corridor management plan; and

WHEREAS, in the process of developing this corridor management plan, the Harriet Tubman Underground Railroad New York Scenic Byway Steering Committee has strengthened the bonds of inter-municipal cooperation, and the involved entities envision further benefit through scenic byway designation including sustained collaborative progress, increased funding opportunities for recommendations identified in the plan, enhanced partnerships with agencies responsible for the stewardship of resources along and adjacent to the byway route, and an improved transportation experience that preserves, interprets, and promotes the corridor's intrinsic qualities and resources; and

NOW, THEREFORE, BE IT RESOLVED, that the Village of Chittenango supports the designation of the Harriet Tubman Underground Railroad New York Scenic Byway which includes programs for stewardship and enhancement of the scenic byway and guidance to manage future activities along its corridor; and

BE IT FURTHER RESOLVED, that the Village of Chittenango supports the designation of the Harriet Tubman Underground Railroad New York Scenic Byway which Town of Sullivan confirms that they will not approve any requests for new off-premise outdoor advertising signs along the designated Harriet Tubman Underground Railroad New York Scenic Byway route; and

BE IT FURTHER RESOLVED, that the Village of Chittenango supports the designation of the Harriet Tubman Underground Railroad New York Scenic Byway which will work in partnership with the other municipalities along the Harriet Tubman Underground Railroad New York Scenic Byway and local and regional stakeholders in order to support future Byway program development and collaborate with these interested entities to explore opportunities for cooperation and methods to advance the Scenic Byway.
