NY Forward - Mr. Freunscht advised that the 4th Local Planning Committee meeting went through the list of projects; 82 people attended the public meeting. Survey monkey is being sent out to get input regarding the different projects. The 5th Local Planning Committee meeting will be held on October 15th at which time the project list will be pared down. Two weeks after that, the projects list will be finalized. There is \$6 million available – 1.5 million will remain in queue.

Empire Access is a new County wireless cable network that is currently being installed along Genesee Street, down Madison Street toward Perryville. The purpose of this company is to serve people who do not have good cable available to them at present. Check the Village Facebook page for more information. The Village does not have a franchise agreement with Empire Access.

Health & Safety Committee Meeting was held on September 15th. Nothing to report. Mr. Freunscht advised that attendance was good with the exception that there was no representative from the Police Department and the Village Board. New Business

Dan Cunningham – Wastewater Treatment Plant Update

Mr. Cunningham reviewed the yearly totals included in the WWTP Report. He advised that the old leachate tank has been converted to another storage tank. The bar screen is running all the time. He will hire an electrician to check the sensor. New RAS pumps are expected to be delivered next month (RAS pumps return the activated sludge)

Village Administrator/DPW – Sewer Service Request

Mr. Freunschdt advised that a property owner on Bolivar Road requested to be hooked up to the Village sewer. His property is contiguous with Village property. It was suggested that he would have to annex his property with the Village and install a 500-foot main from his house to Horizon Drive.

Bulk Trash Refund Request (not village resident)

A Town of Sullivan resident paid \$20 online to have a sofa picked up. It was explained to him that the bulk trash pickup is for Village residents only.

Trustee Baldwin made a motion to refund the \$20. Trustee Kopp seconded the motion. All in favor. Motion carried.

The \$20 will be returned to the Town of Sullivan resident and the Village website will be updated to state FOR VILLAGE RESIDENTS ONLY.

Trustee Wehner made a motion to appoint Colleen Baldwin, Village Trustee, as the Climate Smart Community Coordinator. Trustee Kopp seconded the motion. All in favor. Motion carried.

RESOLUTION TO IMPLEMENT A CLIMATE SMART COMMUNITY TASK FORCE AND
APPOINT A CLIMATE SMART COMMUNITY COORDINATOR

WHEREAS, The Village of Chittenango adopted the New York State Climate Smart Communities Pledge by Resolution on September 25, 2025; and

WHEREAS, the Village of Chittenango wishes to obtain Certification under the Climate Smart Communities (CSC) Program by taking proactive steps towards reducing greenhouse gas emissions and adapting to climate change; and

WHEREAS, a Climate Smart Community Task Force serves as a central body of leadership that promotes and supports climate change mitigation and adaptation strategies within the community and will act as an advisory group to the municipality on any community issues related to climate change; and

WHEREAS, the CSC Task Force will meet at least twice a year and maintain meeting minutes and attendance records for each meeting; and

WHEREAS, the CSC Task Force will consist of community members, municipal representatives, and other relevant stakeholders; and

WHEREAS, a CSC Coordinator is responsible for convening and managing the task force as Chair, serving as a liaison between the CSC task force and the chief executive officer and other officials, and interfacing with the New York State Department of Environmental Conservation on the CSC program as needed.

THEREFORE, IT IS HEREBY RESOLVED that a Climate Smart Community Task Force be initiated with the initial membership list below; and

BE IT FURTHER RESOLVED that The Village of Chittenango appoints Colleen C Baldwin, Village Trustee as the Climate Smart Community Coordinator.
